MCRCF Membership Application Information

Membership Classes and Dues

All members of all classes (except non-flying members) must hold a current AMA membership for the application year. Annual dues are currently:

Membership Classes: Regular and Senior - - \$75.00

Family (Exempt from initiation fee) - \$30.00 **Junior** (Exempt from initiation fee) - \$ 5.00

See the MCRCF By-Laws for complete descriptions of membership classes. A *Junior* member is <u>less than 19 years old *</u>. A *Senior* member is <u>60 years old or older *</u>. *Family* and *Junior* members are additional member in the immediate family of and residing at the same address as a Regular / Senior member paying full dues. *Non-Flying Members* are members of any class who have declared that they will not fly during this membership year. Channel selection and AMA membership proof are not required for non-flying members. No frequency tags will be issued. *(Jr. and Sr. ages are as of March 1 of the current flying year.)

Initiation and Late Renewal Fees

A \$25.00 initiation fee will be charged to all NEW Regular and Senior members. Family and Junior members are exempt from the initiation fee.

Late Renewal: Renewal applications postmarked on March 1st or later <u>must include the \$25.00 fee</u> (except for Juniors and Family members.)

Late application/Early Renewal: Applications received on or after 1 October are good for membership through the following calendar year.

Frequency Tags (Please read this section. ID or Frequency pin should be displayed when flying. Members flying with FM radios *must* display their frequency pin on the frequency pole.

Your unique looking MCRCF frequency tag is replaced yearly, and will serve as your club membership card while operating at the field. Members are responsible for ensuring that any guests have a current AMA membership and display an appropriate alternative frequency tag on the frequency pole. Guests should also understand and follow all club safety rules and operational procedures.

Members will have their MCRCF frequency tags marked with the official club stamp once they are approved for solo operation. There is strictly NO flying without a Club certified instructor or flight qualifier until you have become a club qualified pilot and your membership card/frequency tag is updated to include "Solo Pilot"

Channels

Please make a separate request for any tags in excess of six, but only if you plan to use them. *If you will use a Spread-Spectrum radio system, use the letters "S-S" for one of your channel numbers.*
